2. This law is enacted pursuant to the authority of Section 10(1)(ii)(a)(1) of the Municipal Home Rule Law of the State of New York.

3. This local law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
