Any person who owns or harbors an animal in the Town of Wayland which

(1) is other than a "domestic animal" as defined in Article 7 of the New York State Agriculture and Markets Law; or

(b) is a dog which is not immunized for rabies when required by law or

(c) is a cat which is not immunized for rabies when required by law shall be responsible to the Town of Wayland for any expense incurred by the Town in the medical treatment of any person or persons required as the result of exposure to such animal.

The Town of Wayland should have the right to bring a civil action against any person so owning or harboring such animal for any such medical expense and the costs and disbursements of the civil action.

This local law shall take effect immediately upon filing with the Secretary of State.
